 - a. F20 Financials update





- KB/Geoff & Shawn have had 1 meeting to discuss F20 financials. They
 are showing roughly a \$60K surplus that is explainable due to lack of
 events once COVID-19 hit. Some funding was left in there and not spend
 (ie: Excellence at \$25K + \$8K for Signature Coaching Conference)
- Staff/board expenses were all savings due to no travel for the summer
- Happy we kept a conservative budget this year to ensure we have some money in the bank going into F21

b. F21 Budget update

- First projection of the F21 budget looks like we'll be operating at a \$40,000 deficit due to no Fall Programs running this year
- Based on where we ended this year, we're in a spot to be able to manage this cost
- We've cut back to ensure that only essentials are included in the budget and it's based on the assumptions that:
 - 25% decrease in membership and all associated events/tournaments
 - There will be Provincial Championship tournaments & others (U10 Jamboree, Eastlink Classic)
 - o Prov Teams will operate to some capacity
 - Re-hire for the operations manager position starting in Jan for an 8-month pro-rated salary

2. President's Update

- Ahead of the 2019 AGM, when Chris MacPhee was asked to join the Executive, it was with the intention that he would be asked to be the President in 2020
- Chris & Peter Crowther had a conversation about it and Chris is interested in the position when it comes up during the appointment of Executive members at the AGM
- 3. Committee's Update (from Search Committee),
 - Peter Crowther meeting with Matt Hornberger
 - Dave MacRae meeting with Darren Tolliver
 - Dave Napier emailed Angie Gillis, who replied but wasn't able to commit
 the time we'd like to keep her on our radar as someone to keep asking
 as she would be a great asset
 - Need to think about diversity in gender when looking at our possible new board members, any other females that are interested?
 - Board to take this away and look to ask some females to have nominations put in

 - High Performance Director
 - Came up in discussions about BNS's NSPPI, a High Performance Committee was added to the PPI and we have not completed it. Thought that a HP Director on the board would be a good happy medium to this





- Diversity & Inclusion Director

 Need a job description for these people and what would their roles/responsibilities be
 - Something to look at later in the year and possibly into next year
